In Maine, the wealthiest 1% pay a smaller percentage of their income in state and local taxes than the middle class, and millionaires pay the same top tax rate as nurses and plumbers.

Tax cuts for the wealthy mean program cuts for you.

- Taxes help pay for important things like schools, roads, and public safety, which benefit
 everyone. Businesses of all sizes also rely on strong public services, a healthy workforce,
 and modern infrastructure to succeed.
- Tax fairness means those with more pay more, while those with less pay less. Asking wealthy individuals and corporations to pay their share is responsible and fair.
- Tax structures that favor the wealthy shift costs to workers and small businesses, making
 life harder for working families. In many states, families with low income pay a bigger share
 of their income in taxes than the wealthy.

Did You Know...?

- A Millionaires Tax in Maine would raise \$200 million per year.
- Ending ineffective Maine corporate tax subsidies would raise over \$100 million.
- Taxing high income from Mainers' capital gains would raise up to \$55 million per year.
- Maine gave away \$12 million in tax credits to a paper company owned by one of the richest families in the world, which shuttered its operations just 5 years later.
- When the <u>Child Tax Credit</u> was expanded during the pandemic, child poverty was cut <u>nearly in half</u>. Despite that impact, Congress let it expire.
- The US loses about \$688 billion in unpaid taxes every year, primarily the result of evasion by wealthy people and corporations.
- On average in the US, the least wealthy 20% of taxpayers pay state and local tax rates that are 60% higher than the wealthiest 1%.
- In 41 states, the wealthiest 1% are taxed at a lower rate than everyone else.
- Over three decades, the net worth of the wealthiest 1% of Americans grew by \$21 trillion, while that of the bottom 50% dropped by \$900 billion. The bottom 50% of American households owns just 2% of the nation's wealth.
